


Global and Korean Air Cargo Market Trends

Major Hong Kong trades see airfreight rates stabilise in August

Major trades out of Hong Kong and Frankfurt saw airfreight rates stabilise in August after months of declines. The latest figures from the Baltic Exchange Airfreight Index (BAI) show that average prices paid by forwarders – both contract and spot – on services from Hong Kong to North America increased to \$4.85 per kg in August compared with £4.69 in July.




It is only the second time rates on the route have increased compared with the preceding month in the last 12 months, the others being in December and March. Rates are lagging 41.8% behind the same month a year ago, although this is an improvement on recent year-on-year performance and prices remain above the pre-Covid 2019 level of \$3.29 per kg. Meanwhile, rates from Hong Kong to Europe in August increased to \$3.65 per kg from \$3.62 per kg a month earlier. The last time rates didn't decline compared with the previous month on the trade was August 2022. Rates on the trade are down 42.4% on a year ago but are up on the \$2.56 per kg recorded in August 2019. There was also an improvement on rates from Frankfurt to North America as prices climbed to \$2.19 per kg

from \$2.13 per kg. It is the first time rates on all three trades have improved in the same month since May 2022. The improvements in rates on the trade in August compared with July mirrors usual seasonal patterns when prices tend to be fairly flat over the summer months. However, as they come off the back of a period of declines, they are perhaps another signal that the market may have reached the bottom. Data provider WorldACD said that global tonnages increased in the third full week of August, following a similar pattern as last year, mainly driven by Europe rebounding from the holiday season, while rates remained stable. ■ Other Airline & Forwarder's information

① WAS: Last March, WAS Co., Ltd., which operates a logistics center in the ICN Free Trade Zone and provides air export/import cargo services and cargo shuttle transportation services within the airport, received approval from the MOLIT for the production and use of special air cargo transport security trucks. Exceptional legal (special) permission was granted. This security truck special is the first case in Korea to be granted suitability for special vehicle production for use within the ICN site, and it has been revealed that Korea's first special permit has been granted.



WAS applied for permission to manufacture a special truck tailored to the size of the aircraft load-only container (ULD) to prevent various types of accidents and damage that occur during air cargo transportation and to ensure safer transportation than before. After completing the acquisition of the truck, To celebrate the special approval, a commemorative vehicle wrapping was completed and the start of full-scale truck operation was announced. In particular, this WAS application for special treatment is part of preparations for the regulated agent terminal project that can replace the security screening role of the airline terminal at the second logistics center with a total floor area of about 20,000 square meters, which began construction in the ICN free trade zone in October last year. . This is done to safely move cargo using specially designed trucks from the company's own logistics center to the cargo terminals of national and foreign airlines, including Korean Air and Asiana Airlines, at Incheon Airport.

- In addition, cargo from regulated customers can also be transported at Was's existing first logistics center. It is planned to be used as a security truck for special transportation to airline cargo terminals. [Cargo Press]
- ② iNOMAD: iNOMAD Co., Ltd. acquired ISO27001 certification, an international standard for establishing and maintaining an information security management system, on the 11th. ISO 27001 is an international standard for information security management systems established by the International Organization for Standardization (ISO) and the International Electrotechnical Commission (IEC). Information is reviewed through a total of four stages of process evaluation: planning, execution, inspection, and action. It is the most authoritative certification in the field of protection. This certification is known to conduct regular reviews every 6 months to 1 year even after selection through strict and detailed verification of physical and technical security, and continuously improves the information security management process and checks whether the certified company complies with standards. It has a reputation for thorough management. Accordingly, it can be said that the scope of iNOMAD 's certification is that the operation of information security system construction, management, and performance in the relevant business field has been verified according to international standards as an international air cargo transportation arrangement service. In other words, as an air cargo platform company, we systematically manage and supervise the air transportation processing information and user information collected and managed under an established security system to strengthen security and further secure customer trust by complying with information security regulations and standards. The significance of this certification lies in the establishment of an environment that can stably expand digital services. Lim Jun-seok, CEO of iNOMAD, said, "iNOMAD's enhanced security capabilities have been recognized through ISO 27001 certification. "This is to improve customer satisfaction through the protection of information operated in digital air cargo transportation services and to realize information security compliance management across the company." "I will try to create a platform," he said. [Cargo Press]
