
■ Forwarders and shippers brace for Q4 hike in air cargo rates

Peak season surcharges and major increases in spot rates are expected, said Niall van de Wouw, chief airfreight officer at Xeneta. "There's a consensus it will be a hot Q4 for air cargo in many Asian markets."

This market warning comes as Xeneta has reported a sixth straight month of double-digit year on year growth in June, although it noted that the comparison is with an overall weak 2023 market and it expects lower demand growth year on year in the second half of 2024 because the fourth quarter of 2023 was stronger than the previous quarters of the year.

Demand in June, measured in chargeable weight, was up 13% year on year, continuing the upward trend seen throughout the first half of 2024. In contrast, cargo supply grew at its slowest pace in 2024, edging up only 3% year on year.

Global air cargo rates hit new high as cargo demand continues to grow



As a result, the global air cargo dynamic load factor – Xeneta's measurement of capacity utilisation based on volume and weight of


cargo flown alongside available capacity – increased by +4% pts year–on–year.

"June's growth in demand was not surprising and we would expect to see a continuation of double-digit year-on-year growth in July and August because of low demand in the same months last year. The global machine is humming along nicely at this level – but this is likely the calm before the storm in terms of air freight rates," said van de Wouw.

"I've heard already that certain airlines and forwarders are thinking of implementing a peak season surcharge by the end of August. There's a consensus it will be a hot Q4 for air cargo in many Asian markets." [Air Cargo News]

① TK: Turkish Cargo continues freighter fleet expansion with 777 order

Turkish Airlines Cargo is looking to further expand its freighter capacity through the addition of extra Boeing 777 freighters.

The fast-growing airline today announced the order of four 777Fs to add to its existing fleet of eight of the aircraft.

Air Cargo News has asked Boeing when the aircraft are due to be delivered.

Turkish Airlines chief cargo officer Ali Türk said: "This new investment in expanding our cargo fleet underscores our commitment to meeting the growing global demand for airfreight services.

"The addition of these Boeing 777 Freighters will not only enhance our operational capabilities, but also serve as another step in our strategic vision to reach the top of air cargo sector worldwide while maintaining our leading position with our unparalleled service and efficiency for our customers across the globe."

Boeing said the additional freighters would help meet growing cargo demand driven by the "rapid growth of e-commerce" and the need for "efficient and reliable transportation".

Paul Righi, vice president of Boeing commercial sales for Eurasia, added: "The 777 freighter's payload capacity, range and flexibility will enable Turkish Airlines to deliver exceptional customer service while maximizing operational efficiency."

The aircraft offers a capacity of 102 metric tonnes and a range of 9.200 km.

The carrier has been expanding its cargo and bellyhold fleet over the past decade and has risen from the 22nd largest cargo carrier with a 1.7% market share in 2015 to number four with a 5.8% market share in 2023. [Air Cargo News]

② OZ : Expansion of international flights during the peak summer season

Asiana Airlines will expand its flights 82 times a week on 22 international routes for the peak summer season. \triangle The U.S. will increase overnight flights between Incheon and New York from five flights a week to seven from July 1 to Sept. 30. \triangle Europe will increase Incheon–Roma flights twice a week from five to seven from July 1 \triangle Incheon–Barcelona flights once a week from three to four from September 1 \triangle The Incheon–Venezia route, which resumed flights once a week from last month, will continue until Oct. 10. \triangle Australia will resume flights between Incheon and Melbourne four

Lufthansa Cargo will open two main cargo flights from Munich to Istanbul from June 6. The flight description is "A321F." It is the first time that the airline has opened a cargo flight in Munich. It will further strengthen its air cargo business in southern Germany. [CargoNews]

4 Maersk: Maersk withdraws bid for DB Schenker

A.P. Moller-Maersk has withdrawn its bid to buy DB Schenker, leaving just three bidders remaining in the acquisition race.

The shipping giant said in a statement shared with Air Cargo News that it made the decision to quit the acquisition process for Deutsche Bahn's freight forwarding subsidiary after it concluded that integrating DB Schenker into the company would involve multiple challenges.

This decision comes after Deutsche Bahn recently narrowed the number of potential buyers of DB Schenker down to four bidders, including Maersk. Initial bids for the forwarder were between \leq 14bn and more than \leq 15bn.

Maersk said that it has carried out a review of DB Schenker's business to assess the strategic fit of the company into Maersk and has also participated in an in-depth due diligence task.

"Following this review, Maersk has decided to withdraw from the process," confirmed the company.

Now the decision by Maersk to withdraw its bid means that only DSV, Saudi shipping company Bahri and a private equity consortium led by CVC remain in the acquisition competition.[Air Cargo News]
