


Global and Korean Air Cargo Market Trends

■ Peak practise as August air cargo spot rates up nearly 25%

Air cargo spot rates were sky high in August as demand and capacity imbalances continued, flanked by additional e-commerce and Red Sea shipping disruption-related demand.

Average spot rates showed their largest year-on-year growth of 24%, according to the latest monthly analysis by Xeneta. Global average air cargo spot rates were recorded at \$2.68 per kg in August. Meanwhile, global cargo supply grew at its slowest ratio in 2024 to date, at 2% year on year, while global cargo demand continued its double-digit growth, rising 11%. In terms of dynamic load factor – Xeneta's measurement of capacity utilisation based on volume and weight of cargo flown alongside available capacity – the supply/demand imbalance led to the global load factor increasing four percentage points year on year to 58% in August. Additionally, there were ocean-to-air shift due to Red Sea disruptions and e-commerce continued to show strong growth

"Typically, air cargo market performance in August tends to follow

the July trend. But another month of double-digit demand growth and the strongest rate growths of the year means there was definitely no summer slack season in 2024," said Niall van de Wouw, Xeneta's chief airfreight officer.


But although year-on-year spot rates were up in August, month-on-month rates were down 1%, likely reflecting a slight cooling of ocean-to-air shift due to ocean shipping frontloading of imports, said Xeneta.

Xeneta's analysis also showed that global air cargo volume growth slowed down in August compared to earlier this year – demand increased 11% year on year in August compared with 14% in July and 13% in June.

But the analyst added that this was anticipated, with the following months likely to follow suit. [Air Cargo News]

 QF: Qantas Freight expands Asia capacity following freighter addition

Qantas Freight will add new frequencies to Asia and New Zealand following the addition of an extra Airbus A321 converted freighter. The Sydney-headquartered airline said the delivery of the A321 freighter will allow it to capitalise on rising demand out of Asia. With this in mind, the carrier plans to add a new Perth-Hong Kong-Sydney loop to two services flying directly between Hong Kong and Sydney using its Airbus 61 tonne capacity A330-200Fs.

The flights from Sydney to Hong Kong will operate from Australia on Wednesdays and Sundays, while the Perth route will operate on Fridays. [AirCargoNews]

2 Atlas Air: Atlas Air orders three 747-8Fs

Atlas Air will add three Boeing 747–8 freighters to its fleet that are expected to enter service late in the third quarter of this year. The New York state–based lessor and cargo airline said the 747–8Fs will help it meet global demand for large widebody airfreight capacity, particularly for cross–border e–commerce shipping.

The three 747–8Fs have been secured through long-term finance lease agreements with BOC Aviation.

In July, Atlas Air secured financing for the purchase of three Boeing 747–400Fs to support e-commerce customers. [AirCargoNews]

③ UO: Hong kong Express, daily flights between Hong Kong and Pennang

Hong Kong Express (UO) will launch a new route linking Malaysia's Penang International Airport (PEN) and Hong Kong from November 21. As a result, Hong Kong Express will be available through a link between Korea (Incheon, Busan, Jeju) and Hong Kong-Penang. The Hong Kong-Penang route will operate once a day. The schedule is 20:10 from Hong Kong, 00:10 from Penang, 00:45 from Penang, and 04:40 from Hong Kong. For Korean flights, both Incheon-Hong Kong-Penang and Busan-Hong Kong-Penang round-trip routes are available for the same-day connection. [CargoNews]

4 Korean Air '6th', Asiana Airlines '23rd'

Korean Air (KE) is the world's sixth-largest air cargo airline as of last year, down one place from the previous year, and Asiana Airlines (OZ) also dropped three places to 23rd in the world.

According to the World Air Transport Statistics (WATS) released by

the International Air Transport Association (IATA), the world's No. 1 airline, which combines international and domestic flights, was Federal Express, which totaled 17.923 billion CTK (1 ton of air cargo) last year. It was down 8.3 percent year-on-year. Qatar Airways (QR) was the world's No. 2 cargo carrier, up 1 percent year-on-year to 14.4 billion CTK.

In third place was UPS, which fell from second place a year earlier. UPS shipped a total of 14.239 billion CTKs over the last year, down 10.4 percent from the previous year. Next came Emirates (EK), which rose 4.8 percent year-on-year to 10.63 billion CTK. In fifth place was Atlas Air of the United States (5Y), which rose 2.8 percent year-on-year to 8.915 billion CTK. Hong Kong's Cathay Pacific Airways (CX) climbed five notches to eighth place in the world, up 40.3 percent year-on-year. Taiwan's China Airlines (CI) dropped four notches, down 16.1 percent year-on-year. [Cargo News]

(5) Hyundai Glovia invests 150Billion Won in Air Incheon

: Securing right to first refusal...Securing 34.9% stake

Hyundai Glovis announced in a management announcement on the 14th that it will invest 150 billion won in Air Incheon (KJ), which will take over Asiana Airlines' cargo division. The investment will be divided into two rounds. After investing 50 billion won in the first round, Air Incheon, which holds a stake through Societies, plans to pay 100 billion won in the second round of investment at the time of the merger when it deals with Asiana Airlines' global cargo transportation business. The share ratio of the investment is 34.9%. Hyundai Glovis explained the background of the investment that it decided to invest in a private equity investment joint venture (PEF) based on Air Incheon, which operates an air cargo transportation business, to strengthen its competitiveness in the air logistics business.
