Global and Korean Air Cargo Market Trends

Kong airfreight rates flatten in March

Airfreight rates on key trade lanes out of Hong Kong were flat in March but remain ahead of the year-ago level.

The latest figures from the Baltic Exchange Airfreight Index, based on TAC data, show that average rates, based on both spot and contract, from Hong Kong to North America declined by 1.5% compared with a month earlier to \$5.29 per kg. Compared with last year, rates on the trade are up 8.4%.

Meanwhile, from Hong Kong to Europe rates in March were up 0.5% to \$4.39 per kg, while they are up 12% on last year's levels. March tends to see rates start to flatten off after the Christmas and Lunar New Year swings that affect the market in December, January and February.

TAC pointed out that the year-on-year rate performance in March was "impressively strong" given that last year prices were already strong due to the Red Sea crisis and surging e-commerce volumes. "Over the last year to 28 March, jet fuel prices also fell an average of 7.8%, according to data from Platts," TAC added. "Higher rates combined with lower fuel costs should thus be boosting margins for carriers."

"Sources largely agreed about the main reason rates were rising overall, particularly in the last two or three weeks of the month – the primary driver being impending tariffs that will be imposed in the US after 2 April."

Looking ahead, the market outlook is uncertain, according to TAC, given the "erratic pattern of on-again, off-again announcements about tariffs coming out of the White House".

"All of this has also made it more difficult for market participants – including airlines, forwarders, and shippers – to plan ahead with confidence," TAC editor Neil Wilson said.

"That is also before taking into account the potential responses of other trading partners – and all the uncertainties about that." [AirCargoNews]


Airfreight Rates – Baltic Exchange Airfreight Index

① Lufthansa Cargo's Poland freighter flights get underway

Lufthansa Cargo has launched regular Airbus A321 freighter flights between Frankfurt Airport and Katowice Airport.

The first flight of the new service, which was announced back in February, arrived at 16:00hrs yesterday with the flight back to Germany leaving around an hour and a half later.

Yesterday's flight marked the start of the airline's twice-weekly service to the Polish airport.

Flights between Katowice Airport and Frankfurt are an expansion of Lufthansa Cargo's current offer in Poland.

In January 2021, Lufthansa Cargo launched a Road Feeder Service (RFS) freight consolidation facility for Poland in the Katowice Airport cargo terminal.

Wojciech Ryglewicz, director sales & handling central & eastern Europe at Lufthansa Cargo, said: "The launch of a regular cargo route between Frankfurt and Katowice is not only a further step in the development of our operational network in central and eastern Europe, but above all a response to the growing needs of industry in the region.

"Nowadays, fast and reliable air transport is a key component of supply chains, enabling companies to operate efficiently in a globally competitive environment.

"We are certain that the new connection will be a real support for the dynamically developing industrial sector and will contribute to building Poland's long-term economic potential."

Artur Tomasik, the president of the board of the Upper Silesian Aviation Group, added: "[The] launch of Lufthansa Cargo regular flights on the Frankfurt - Katowice - Frankfurt route is an important moment when it comes to development of cargo at Katowice Airport. "We are the first Polish airport where Lufthansa Cargo began handling regular cargo flights; undoubtedly, it emphasises the significance of our airport in the area of air cargo in Central Europe." 2 Asiana Airlines : Partial reduction of European routes from April

The reduction of Asiana Airlines (OZ) is a corrective measure by the European Union (EU) competition authorities to resolve concerns over monopoly on European routes, and Asiana Airlines stopped selling scheduled flights at the same time as its incorporation into Korean Air's subsidiary on December 12 last year.

Some of Asiana Airlines' transportation rights on its three European

routes (Frankfurter, Paris, and Rome) are transferred to national airlines, and the national carrier's supply power to Europe remains the same

Starting from April 25, Asiana Airlines will reduce the Incheon-Roman route from five times a week to four times a week, and from Wednesday, it will reduce the Incheon-Frank Frankfurt route from seven times a week to four times a week. Starting from May 12. Incheon-Paris routes will also be reduced from six times a week to five times a week. [Cargo News]

③ Ethiopian begins China-Spain cargo route

Ethiopian Airlines has begun operating a cargo charter route from Macao International in China to Adolfo Suárez Madrid-Barajas Airport in Spain.

The flight was carried out using a Boeing 777 freighter and departed this morning, according to a story from China's state press agency Xinhua

This new cargo route will initially operate twice a week, with exports including toys, small appliances, furniture, electronics, auto parts, clothing and cosmetics.

The new route is expected to bring over 20,000 tons of cross-border cargo throughput to Macao annually.

Ethiopian Airlines has previously launched cargo routes in Shenzhen, Guangzhou, and Hong Kong.

In December, Ethiopian Airlines Group signed a strategic cooperation agreement with Xiamen Iport Group and a memorandum of understanding with China Henan Aviation Group (CHAG).

The airline's country director for China, Aman Wole Gurmu, noted the new route's potential to strengthen collaboration with e-commerce supply chains in the Greater Bay Area.

In January, Ethiopian Cargo added a new Boeing 777 freighter to its fleet to help it continue to grow global operations.

Data from Planespotters shows that the aircraft is Ethiopian's 11th 777F and the airline's fleet also currently includes four converted 737-800Fs; three converted 767-300Fs and two newbuild 767-300Fs, which were delivered in December.

Ethiopian Airlines serves 70 dedicated cargo and 140+ passenger destinations in Africa, the Middle East, Asia, Europe, and the Americas [AirCargoNews]

④ YP: HNL regular flights in July, more U.S. western routes from Mav

Air Premia (CEO: Kim Jae-hyun, Yoo Myung-seop) will operate four flights a week on the Honolulu (HNL) route in Hawaii from July 2. With the launch of Honolulu, the airline will operate a total of four regular flights (LA, New York, San Francisco, and Honolulu) in the

Americas alone. It departs from Incheon International Airport every Monday, Wednesday, Friday, and Saturday at 10:30 p.m. and arrives at Honolulu International Airport at 11:50 a.m. local time.

It will also increase the number of Los Angeles (LAX) and San Francisco (SFO) routes from May. The Los Angeles route will be operated seven times a week from May 30 to July 5, plus Monday, Wednesday, and Friday nights. After that, from July 6, a single night



flight will be added on Sundays, for a total of 11 flights a week.

The San Francisco route will also be added on Saturdays from May 10, adding one more from four weekly (Monday, Wednesday, Friday, and Sunday) to five weekly flights.

To commemorate the increase, the airline will also hold a special promotion to commemorate the increase in LA and San Francisco routes from March 26 to April 2. [Cargo News]

(5) Korean Air Orders 50 Advanced Airplanes To Boeing

: Malaysia Airlines also orders up to 60 'B737' units

Korean Air said it will strengthen cooperation with Boeing and GE Aerospace. This is to prepare for global aircraft supply chain problems and introduce next-generation air force in a timely manner.

Hanjin Group Chairman Cho Won-tae, Chief Executive Officer Kelly Ottberg Boeing, and General Manager Russell Stokes of GE Aerospace's engine and service division met in Washington, D.C., on the morning of the 21st local time to discuss ways to strengthen cooperation.

Korean Air is actively introducing the latest next-generation aircraft to expand and upgrade its fleet in line with the launch of an integrated airline. In particular, the strategy is to secure the supply of aircraft early and carry out mid- to long-term entry plans without a hitch amid rising demand for new aircraft around the world.

To this end, Korean Air has decided to complete the implementation of a memorandum of understanding (MOU) with Boeing at the "Fanborough International Air Show" in July last year. They discussed the possibility of introducing 20 Boeing 777–9s and 20 Boeing 787– 10s by 2033, and purchasing 10 more aircraft under similar conditions in the future.

In addition, the company will purchase eight spare engines (two optional engines separately) and complete the contract for GE9X engine-related maintenance services for Boeing 777-9 aircraft as soon as possible to strengthen the manufacturer's support for aircraft and engines. The three companies' cooperation totaled \$32.7 billion (about 47.97 trillion won) with \$24.9 billion in aircraft purchases and \$7.8 billion in spare engine purchases and engine maintenance services. [Cargo News]

⑥ Canada to implement air cargo pre-reporting system in April

: Transportation restrictions if information is not submitted

The Trasport Canada will implement an electronic submission system for pre-air cargo information before boarding an aircraft from April 1. As a result, special attention from domestic forwarders is required.

The system is called "PACT (Pre-load Air Cargo Targeting)." It aims to strengthen air cargo security measures. Airlines must transmit cargo information (FWB/FHL) to Canadian authorities to obtain permission to board the aircraft before boarding.

Although the reporting entity is the airline, forwarders must also comply with the "PACT" requirements because they play an important

role in the preparation of cargo documents and data transmission. The information to be transmitted is the name and address of the sender, the name and address of the receiver, item, quantity, weight, MWB, HOWB number, etc.

If inaccurate FWB/FHL is transmitted, transportation may be restricted by pending approval or non-approval from the Canadian government. [Cargo News]

⑦ DHL-Temu Signs Cooperation to Support Logistics in Europe

DHL Group recently signed a partnership with Temu, a Chinese ecommerce company, and announced that it will strengthen logistics support.

Through this partnership, DHL will support Temu's logistics in Europe. It also plans to strengthen its logistics support not only in the Middle East but also in Africa through the logistics support it has established in Europe [Cargo News]
