

Global and Korean Air Cargo Market Trends

Xeneta: Volumes flat in June as consumers scale back



The growth in global air cargo volumes came to a standstill in June

Air cargo volumes could drop as consumers scale back on nonessential goods, while shippers are favouring shorter-term contracts in a climate of uncertainty.

Niall van de Wouw, Xeneta's chief airfreight officer, said consumers are looking to save money amid concerns about international trade. Global air cargo volumes were flat in June, up just 1% year on year, while available capacity, measured over the same period, increased 2%.

Global air cargo spot rates declined for a second consecutive month in June, down -4% year-on-year as supply of capacity overtook demand for the first time in 19 months.

"The air cargo market is losing altitude amidst so much uncertainty," van de Wouw said. "For consumers who were already under severe financial pressure from the rise in the everyday cost-of-living, the

added cost of tariffs means they are more likely to think twice about buying many of the types of goods which are exported and imported by air."

Despite the disruption from changes to tariffs and e-commerce (de minimis) in the first half of the year, air cargo demand still grew by 3% in that period compared to the same period a year earlier. But ongoing tariff and de minimis issues mean the industry is likely

not to fare as well in the second half of the year.

Lower rates will unlikely be an incentive for shippers, and the focus should be on deteriorating demand due to weaker consumer confidence, suggested van de Wouw.

There are several areas of uncertainty for the market, he pointed out.


The temporary suspension of new US tariffs is set to expire on 9 July for most countries – and on 13 August for China – clouding forward–looking demand.

Simultaneously, a spike in crude oil and jet fuel prices, caused by conflict in the Middle East, has yet to lift freight rates because air cargo pricing remains more tightly tethered to market forces than to input costs, he said.

Compounding this trepidation is a weakening US dollar. As most airfreight contracts are denominated in local currencies, the around 5 % depreciation (across several US dollar indices) of the dollar has diminished the headline decline in dollar-based spot rates. The global dynamic load factor for air cargo in June reflected the market's downward trend, falling 2 percentage points year-to-year to 56%. Dynamic load factor is Xeneta's measurement of capacity utilisation based on volume and weight of cargo flown alongside available capacity.



Air cargo spot rates show mixed trends across major corridors vs a year earlier



Most airfreight corridors recorded year-on-year rate declines in June, underscoring a broad market slowdown, Xeneta's data showed.

Routes from Southeast Asia to both Europe and North America were particularly weak, posting double-digit drops in rates compared with the same period last year when prices had spiked. In comparison, the Northeast Asia to Europe corridor remained relatively steady. A surge in e-commerce volumes helped offset a shift in capacity toward the Asia-Europe market, keeping rates in balance.

Backhaul routes from Europe and North America to Asia, however, continued their downward trend, reflecting persistent trade imbalances.

Only a handful of corridors defied the broader pattern. Rates from Northeast Asia to North America climbed modestly, driven by nervousness over the approaching end of the US' 90-day tariff truce.


Transatlantic routes also edged higher: both westbound and eastbound spot rates posted single-digit increases year on year. Alongside changes to demand and rates, Xeneta's analysis suggested shippers are now beginning to favour short-term capacity contracts with forwarders over longer ones in the uncertain operating conditions.

The second quarter, typically the peak season for tendering, saw a notable shift. The share of mid-term contracts (three to six months) rose by eight percentage points compared to a year earlier, largely at the expense of annual or longer-term agreements.

That said, compared to the first quarter, the share of three-month contracts declined 12 percentage points. This indicates that some tenders earlier in the year proceeded out of necessity, particularly for shippers who place a premium on service reliability, stated Xeneta.


Meanwhile, freight forwarders are currently opting for capacity flexibility over long-term commitments while they wait to see what will happen to rates. As of June, around 46% of their procured volumes remain in the spot market. [AirCargoNews]



① FedEx begins first direct South Korea-Taiwan flights

FedEx has launched its first direct flight between South Korea and Taiwan to support air cargo demand for electronics, semiconductors, and e-commerce.

This new flight route, which operates seven days a week, connects South Korea via the FedEx Incheon Gateway at Incheon International Airport with Taiwan via the FedEx Taipei Gateway at Taoyuan International Airport.

The new route boosts operational efficiency for exporters and importers between the two markets, a critical trade lane for high-tech industries.

"The new direct flight underscores our commitment to our customers by supporting the growing exchange between South Korea and Taiwan, especially in electronics, semiconductors, and e-commerce fueled by K-culture goods," said Wonbin Park, managing director of FedEx Korea.

"Capacity, flexibility and reliability are crucial for building resilient, competitive supply chains. With the new route, we are empowering our customers with a stronger foundation for cross-border business growth opportunities within the Asia Pacific."

FedEx said customers in South Korea will benefit from extended callin cut-off and gateway drop-off times by up to 3.5 hours for airfreight shipments using FedEx International Priority Freight and FedEx International Priority Economy.

Trade between South Korea and Taiwan has remained robust, particularly in the semiconductor industry amid the global surge in artificial intelligence (AI) development, with South Korea currently Taiwan's fifth largest export market and fourth largest import source, noted FedEx.

As key players in the semiconductor sector, both countries are intensifying their AI supply chain collaboration. According to South Korea's Ministry of Trade, Industry and Energy (MOTIE), the country's semiconductor exports reached a record \$141.9bn in 2024.

From January to November 2024, the share of chip exports to Taiwan rose significantly from 6.4% in 2020 to 14.5%.

Amid the boom of the semiconductor industry, FedEx expects the new flight route to further strengthen connectivity and operational efficiency for manufacturers, particularly in the high-tech sectors.

This new flight route is part of FedEx's on-going efforts to strengthen its global air network.

In April 2025, FedEx launched its first direct flight from Singapore to

Anchorage, US, strengthening connectivity between Southeast Asia and major US markets.

Last month, FedEx Express celebrated the 40th anniversary of its inaugural scheduled transatlantic service. [Source:AirCargoNews]

2 Air Premia (YP): new Honolulu launch

Air Premia (YP) has launched new Incheon and Honolulu (HNL) routes.

The first regular flight from Incheon International Airport to Honolulu was operated from Incheon International Airport Terminal 1 on the night of the 2nd. The first boarding rate of the route was around 90 percent, signaling a smooth start. It will operate four regular flights per week (Monday, Wednesday, Friday, and Saturday). [Source: Cargo News]

③ DHL Global Forwarding opens new Frankfurt airfreight hub

DHL Global Forwarding has officially opened its new airfreight hub at Frankfurt Airport, which consolidates its various sites at the airport.The new 300,000 ton capacity terminal is located at CargoCity Süd, measures 24,500 sq m and features 54 cross-docks. The forwarder said that the consolidation of its operations at the airport would result in a "more efficient handling of airfreight, fewer truck movements, and shorter distances for employees handling or transferring cargo".

The company added that the facility would also position it for future growth.

DHL Global Forwarding Europe chief executive Tobias Schmidt said: "Frankfurt, with its central location in Europe, has become increasingly important to us as an airfreight hub over the years.

"This establishes the ideal framework for us to manage our growing transport volumes even more efficiently, quickly, and sustainably." The terminal also offers 3,000 sq m of flexible office and social spaces and accommodates the European headquarters of the in-house airfreight operator StarBroker, which is responsible for booking and coordinating airfreight capacities for DHL Global Forwarding and managing controlled flight operations

The new hub facilitates services such as consolidation and deconsolidation of airfreight, customs clearance, handling for onward transport by truck, and organisation of charter capacities. Fraport, the owner and operator of Frankfurt Airport (FRA), has leased the property space to DHL Global Forwarding and worked on the development project with the forwarder.

Anke Giesen, executive board member for retail and real estate at Fraport, said: "With the Master Plan Cargohub, Fraport aims to increase cargo volumes by over 50%, reaching approximately 3m tons of airfreight per year by 2040. The new site, with an annual turnover of 300,000 tons of freight, is a key component." [Source:AirCargoNews]
